Planning and Advanced Reservation of Capacity Agreement (PARCA) NOTICE: PARCA APPLICATION – ALLOCATION OF NTS EXIT CAPACITY 18th May 2020

Dear Industry Colleague,

In accordance with Uniform Network Code, Section B, we are issuing this notice to all interested parties.

On 16th January 2019, we issued a notice with respect to the receipt of a competent Planning & Advanced Reservation of Capacity Agreement ("PARCA") application. The PARCA application was for National Transmission System ("NTS") exit capacity of between 5,980,500 and 7,310,160 kWh/d in the North East, Yorkshire and Lincolnshire (Region 3 in the Gas Ten Year Statement¹). The indicative capacity Registration Date specified at the time was 1st December 2019.

On 29th April 2019, we issued a notice ("Saltholme ExCS Informal Notice (including exit Substitution & Baseline Revision)"). The informal notice confirmed that the PARCA Phase 1 Works had been completed to meet a capacity requirement of 7,310,160 kWh/d for a capacity Registration Date of 1st December 2019.

On 24th September, we issued a notice to advise that the Registration Date had been revised following a request from the Reservation Party, with capacity release proposed as follows;

From 1st June 2020

• The quantity of Enduring Annual NTS Exit (Flat) Capacity reserved at the NTS Exit Point and proposed for release as non-obligated Exit Capacity is 7,310,160 kWh/d.

From 1st October 2020

The quantity of Enduring Annual NTS Exit (Flat) Capacity reserved from each donor NTS Exit Point for the purposes of exit capacity substitution is as follows:
