2020/21 Baseline Volume Target Audit

In our opinion, the methodologies and rules set out in the "NTS Shrinkage Incentive Methodology Statement, June 2019" have been correctly applied for Compressor Fuel Use (CFU), Calorific Value Shrinkage (CVS) and Unaccounted for Gas (UAG). The final audited baseline volumes for 2020/21 are therefore as follows:

2020/21 Efficiency Volume Target Audit

In our opinion the methodologies and rules set out in the "NTS Shrinkage Incentive Methodology Statement, June 2019" have been correctly applied. In particular, the audit has confirmed that:

• The Energy Efficiency Target for CFU (Compressor Fuel Use) has been correctly calculated as 1,544.4 GWh against an outturn of 1,546.1 GWh, with an upper tolerance of 199.2 GWh and a lower tolerance of -166.1 GWh. This results in a final CFU Energy Efficiency value of 0 GWh.

• The Energy Efficiency tolerance band for CVS (Calorific Value Shrinkage) has been correctly calculated as 29.5 GWh to 31.8 GWh against an outturn of 236.3 GWh. This results in a final CVS Energy Efficiency value of -204.6 GWh.

2020/21 Adherence to Publication Dates

- The documents "2020/21 NTS Shrinkage Incentive Methodology Statement" and "2020/21 NTS Shrinkage Incentive Ex-Ante Baseline Value Statement" were both published in line with the required timescales. This was verified at the time of publication.
- The 2020/21 Baseline targets were updated with UAG values for Q3 2020, Q4 2020 and Q1 2021 by the required publication dates. This was verified at the time of publication in each case.
