### RE: OPERATING MARGINS ("OM") - INVITATION TO TENDER - Ariba Reference: WS1688428508

This Invitation to Tender is made in respect of National Gas Transmission plc's ("National Gas") latest OM procurement exercise.

#### **OM Service Requirement**

The Gas OM Service enables the delivery of a change in the rate of gas flow to or off-taken from the NTS which manages sudden changes in supply or demand that cannot be met by normal trading/balancing arrangements. In addition, OM allows time for National Gas to reconfigure the NTS or for the market to deliver additional supply and can protect against the need to declare emergency conditions to ensure normal commercial market operation can be maintained where possible. In the event of an emergency, OM can also be used to manage the safe and orderly rundown of the NTS.

National Gas procures capacity and access to a volume of gas for OM on an annual basis in line with both the requirements of Section K of the Uniform Network Code (UNC) and the obligations detailed in the National Gas Safety Case.

Tenders are invited from Storage, LNG Importation with Storage, or Demand Reduction service providers to meet the 2024/25 forecast OM requirement of 919 GWh.

# Changes for the 2024/25 Tender

Following feedback from previous tenders, there are two important changes that participants should note for the 2024/25 tender.

- The Gas Capacity (Storage) Agreement has now been split into two variants:
  - o One contract for where the Service Provider is the Facility Operator
  - One contract for where the Service Provider is a 3rd party User at a Storage site

Tender packs have been developed in accordance with the above, tender pack 1a is to be completed by OM providers who are also the Facility Operator and 1b is to be completed by a third party who is a Storage User of the relevant facility. If you are unclear as to which tender pack to complete, then please contact us.

• **Credit Security provision** - the addition of Deposit Deed as an additional credit cover within the Gas Capacity agreement, this can be found within Schedule 7.



#### E-sourcing

National Gas will be using the electronic ARIBA portal for the submission of tender responses, and encourage you to register on ARIBA, if you do not have an account and, or wish to familiarise yourself with the portal by Wednesday 22<sup>nd</sup> November 2023; in order for you to gain access and prepare for tender submission. Alternative methods of tender submission are not allowed.

### **OM Contract Terms**

National Gas is subject to its Gas Transporter Licence obligations to ensure a tenderer does not obtain any unfair commercial advantage from a preferential or discriminatory arrangement as against another tenderer. This means that National Gas cannot substantially deviate from the terms published in the template OM Agreement. Therefore, proposed contractual amendments should only be submitted if they are deemed reasonably necessary to reflect the type and technical characteristics of the relevant site. Any changes that tenderers wish to propose to these template OM Agreement terms (or alternative terms) must be captured on the standalone



OM Tenderers Contract Response Form, must be submitted to Richard Loukes (richard.loukes@nationalgas.com) and Andrea Godden (andrea.godden@nationalgas.com) no later than 13:00 (GMT) on Monday 11<sup>th</sup> December 2023. Such proposed amendments will be factored into the assessment of the tenders.
