National Grid Metering Charges from 1st April 2008

Please find attached schedules showing National Grid's revised metering charges to apply from 1st April 2008 This notification is provided 3 months in advance of the effective date consistent with the notice period required in National Grid's Metering contracts¹.

National Grid's metering charges are regulated by a price control set by Ofgem, the gas industry regulator. To achieve price control, Ofgem has set tariff caps for four key metering services. National Grid's charges for these services must not exceed the tariff caps, which are increased each year by inflation (RPI).

In general, the revised rental charges effective from 1^{st} April 2008 incorporate an increase of 4.1% in respect of inflation. The domestic annual rental charges are set to the regulated tariff caps and are £14.10 for a credit meter and £32.92 for a prepayment meter.

The annual rental charges for Industrial and Commercial meters are also increased in line with inflation with rebalancing of charges between meter types to achieve better cost reflectivity. The rebalancing of charges in 2008/9 concludes the approach (to rebalance over 2 years) announced last year (18th December 2006).

National Grid is also adjusting its transaction charges for meter works to achieve better cost reflectivity. The impact of using latest costs, some of which have increased by more than inflation, is an overall increase in transaction charges of 9% although there is a mix of increases and reductions for individual charges. The transaction charge for domestic meter exchange has been set at £57.72 the level of the regulated tariff cap.

Any work downstream of the outlet of the meter is excluded unless specifically mentioned. In all cases, service pipe installation, alteration and disconnection and meter box provision is excluded and will be subject to additional charges.

The following charges relate to domestic-size meter installations, where the meter capacity is less than 11 standard cubic metres per hour (scmh).

Daily Meter Reading services

The Annual charge for Daily Meter (DM) reading has been set to the tariff cap of £426.58. This charge is calculated on a daily basis, at 116.87 pence per day.
