## **API transition update: Moving towards REST**

As part of our ongoing transformation journey, we launched our new **Representational State Transfer (REST) APIs** in November 2024. These include a new **Data Item** and **Instantaneous Flow** service using the REST architecture. This new approach offers a more efficient, reliable and industry-aligned method for accessing our data.

Since the launch, we've seen a growing number of our users successfully transition to the new REST APIs. We understand that many stakeholders rely heavily on our API services, and we are committed to supporting a smooth migration.

To ensure everyone has sufficient time to make the switch, we are providing an extended transition period. Please note that during the first half of 2026, we will begin phasing out our legacy SOAP APIs, which will be fully decommissioned thereafter.

We encourage all users to begin planning their migration to REST if they haven't already. For more information on our REST APIs, please visit our <u>Gas Data Portal REST API</u> page.

## Coming this September: New Gas Quality Data feature

We are excited to announce that a new **Gas Quality Data** feature will go live on the Gas Data Portal this September, making it easier than ever to access and interpret real-time gas quality information.

With this new functionality, you'll be able to:

- View seven key telemetric values of gas quality data
- Access both real-time and historical data in clear chart and graph formats
- • See a Five-Year Wobbe Index Forward Outlook for Delivery Facility Operators (DFOs) who've applied to lower their Wobbe limits

This enhanced transparency helps reduce the risk of damage to pipelines and equipment and supports compliance with **GS(M)R** regulatory standards, benefiting both network operators and customers alike.

Stay tuned for further updates as we get closer to launch!
