RE: Indicative Notice of Revised General Non-Transmission Services Charges to apply from 1 October 2025

Dear Industry Participant

We understand the benefit additional information can provide and where possible the ability to give an indicative view of the General Non-Transmission Services charges, the most significant of the non-transmission Services charges, alongside the Transmission Services charges will hopefully be of use to Stakeholders and Customers.

This indicative notice is issued alongside the final Transmission Services notices to help better inform the revision to Charges across both Transmission Services and General Non-Transmission Services charges that will come into effect on 1 October 2025.

It is essential to note the General Non-Transmission Services charges in this notice are indicative only and will be subject to change ahead of their final publication. The Final General Non-Transmission Services charges, that will be issued with all the applicable non-transmission Services charges, will be published by the end of July 2025.

The charges included in this notice are calculated in accordance with Section Y of the Uniform Network Code, and UNC Code Modification [0857](#) which was approved for implementation from 1 October 2024.

Please note: the charges for Gas Year 2025-26 are based upon the System Operator (SO) allowed revenues determined through the Price Control Financial Model ([PCFM¹](#)) as at May 2025. Future year indicative prices for 26/27 to 29/30 use National Gas' [Business Plan Financial Model²](#). Final determinations for RIIO-T3, that will inform the Allowed Revenues for the five-year period from April 2026, have not yet been issued and are not expected until later this year. To have revenues for this period to help inform the calculation of prices for October 2025 and indicatives for the four subsequent years, Revenues for the Regulatory years starting April 2026 are based on National Gas Business Plan Financial Model that has been published as part of our RIIO-T3 Business Plan submissions to Ofgem

The table below highlights the combined Transmission Services and General Non-Transmission Services prices for Entry, Exit and in total across the prices that are in place from October 24 and the Final Transmission Services prices and Indicative General Non-Transmission Services prices for October 25.
